Exclusions

Package costs do not include items of a personal nature, such as meals and beverages, local or long-distance phone calls, laundry, room service charges, entrance fees not mentioned in the itinerary, gratuities, etc.

Porterage, meals, beverages, room service, pay-per-view, mini-bar, long-distance calls, and all other hotel charges are not included. All such hotel charges incurred are the guest's responsibility, and the room bill must be settled upon check-out. A credit card number will be required upon check-in.

This package does not include transportation to/from Calgary, transportation between the hotel and the arrival/departure point(s), or transportation between the included activities and the hotel.

Gratuities are not included, where applicable and unless otherwise stated. Additional fees may apply, such as but not limited to baggage, meal, or seat selection fees for flights, or resort fees, service charges, or municipal taxes at hotels.

Cancellation and/or modification fees may apply even where none are specified. Extensive travel insurance including trip cancellation and interruption coverage is highly recommended.

Canadian health insurance is almost certainly *not valid outside of Canada*. Provincial or territorial health plans may *cover nothing or only a very small portion of the costs of medical care outside of one's home province*, and never up front. The Government of Canada will not pay for a traveller's medical bills.

COVID-19 Information

Heritage Park Historical Village

As the province has removed most public health measures and the city has moved to be in line with the provincial regulations, Heritage Park has removed indoor and outdoor social gathering limits as well as masking requirements throughout the park.

You will still see staff at the park wearing masks and that will continue for the foreseeable future.

Stampede Park

The Calgary Stampede remains committed to meeting and exceeding all current public health measures to continue to make Stampede Park a safe gathering place for the community. The Stampede will continue to adjust and implement applicable measures with the understanding that safety and guest expectations will continue to evolve as we get closer to July.

Calgary Marriott Downtown Hotel

As part of Marriott International's family of brands, the Calgary Marriott Downtown Hotel has implemented a variety of new protocols and elevated practices in response to the COVID-19 pandemic and keeping with the chain's high standards of cleanliness and commitment to providing excellent service.

Every guest room is thoroughly cleaned and disinfected prior to your arrival. During your stay, **the hotel will not provide housekeeping automatically every day. If you wish to receive daily housekeeping refresh service, please let the guest services team know.** They will be happy to make scheduled service according to your preferences.

Signage has been placed throughout the hotel to remind guests to maintain social distancing, occupancy limits, and seating capacity reductions in restaurants in compliance with city and provincial guidelines. Partitions have been installed at front desks and food and beverage service lines.

Valet service is currently available for parking.

The fitness centre is open 24 hours.

The swimming pool and hot tub are both open, but access is limited due to provincial pandemic restrictions and must be booked at the front desk.

The M-Club is closed until further notice due to provincial Covid-19 restrictions.

Through your payment to Journiac Travel & Tours for these travel services, you acknowledge your acceptance of the terms set forth below.

Funds received by Journiac Travel & Tours are held expressly for use in contracting travel arrangements for the client as governed by the Travel Industry Act in Ontario. Journiac Travel & Tours hereby confirms that it is duly licensed to operate as a travel management company under TICO license number 1549342 and carries both consumer Liability and Errors and Omissions insurance. Journiac Travel & Tours operates travel programs under the licensing of the travel agency.

Insurance

Proof of medical insurance is required to participate on this trip.

Trip cancellation/interruption insurance is strongly recommended.

Cancellations & Refunds

Journiac Travel & Tours charges a per person fee for each cancelled reservation, as per the cancellation chart below (taxes included).

Fees of \$40.00 plus tax also apply for each change made to a reservation (such as changes to travel dates, destination, travellers, room occupancy, etc.).

All fees levied by Journiac Travel & Tours are non-refundable.

This package is strictly limited and available on a first-come basis, subject to minimum room and traveller numbers. In the unlikely event that these minimum numbers should not be met, the package may be cancelled by Journiac Travel & Tours, with or without refund of monies paid, as detailed in the cancellation fee chart above. Should this be the case, some travel products and services may still be supplied and rendered despite cancellation, as follows:

- i. If the package is cancelled prior to March 28, 2022, no travel products/services will be supplied/rendered.
- ii. If the package is cancelled on or after March 28, 2022, clients will be provided their admission tickets to the Calgary Stampede, Calgary Tower, and Heritage Park. Hotel accommodations will not be provided. Heritage Park and Calgary Tower admission tickets are valid for one year from the date of purchase/issue. Heritage Park tickets may be exchanged for the following year.
- iii. The package will not be cancelled after May 28, 2020, and all travel products and services will be provided.

This contract permits price increases. No price increases are permitted after the customer has paid in full. If the price increase is more than 7% (except increases resulting from an increase in retail sales tax or federal Goods and Services Tax or Harmonized Sales Tax), the customer has the right to cancel the contract and obtain a full refund.

Client Responsibility

If, in the opinion of any person in a position of authority (such as, for example, a hotel manager), the health, level of fitness, or conduct of a client at any time during the trip is endangering or appears likely to endanger the health or well-being of the client or any third party, or the safe, comfortable, or happy progress of the trip, the client may be excluded from all or part of the package without refund or recompense. Where a client is excluded, Journiac Travel & Tours will have no further responsibility towards them (including any return travel arrangements) and will not meet any expenses or costs incurred as a result of the exclusion. If a client commits an illegal act (including, for example, causing any damage), the client may be excluded from the package and Journiac Travel & Tours shall cease to have responsibility to/for them as above. No refund will be given for any unused services. The client accepts responsibility for any damage or loss he or she may cause. Full payment for any such damage or loss must be made direct to the accommodation owner or manager or other supplier, or to Journiac Travel & Tours as soon as costs are known.
